### Super IRS approved Tax Exempt Charitable contribution to UGMSAF! That cost you virtually nothing!

You may already be aware of this but if not please study this carefully.

At age 72 in the US, anyone who has a 401k is required by the US IRS to begin withdrawing Money from their IRA. This process is referred to by the IRS as Minimum Required Distribution (MRD). It is mandatory. The amount to be withdrawn depends on the value of the IRA account and the life expectancy of the individual.

Qualified Charitable Distribution (QCD) is a term used by the IRS to identify an amount (Up to 100K) that can be given by an individual from their 401K MRD to any charity organization registered in the US at age 70.5. The amount given to Charitable organization does not count towards the individuals tax obligation for the year in which it is given.

Thus, if an individual is in approximately the 33% tax bracket and has total taxable income of 300K, made up of 100k from the IRA and 200k from other sources,(SS, SEP-iRA, stocks, bonds, 1099 etc) the Tax liability of the individual is 100K. If the individual donates 20k of that to a Charitable organization/s from their IRA their tax liability is reduced to 84K. It is either 100k or 84k to the government . Essentially you decide where the money goes.

Certainly, it far more palatable and pleasing to give the government the lesser amount and distribute the difference to charitable organization/s of the individuals choice.

It is our fervent hope that the UGMSAF would be a beneficiary of a large part of your generosity and benevolence this year.

#### February 11, 2024

A year ago, February 2023, the University of Ghana Medical School Alumni Foundation was incorporated in the US with the sole purpose of raising \$1.0M from alumni of the school and the general public to from the cornerstone of a Foundation to benefit the University of Ghana Medical School.

The Foundation has received \$79,080.00 (\$1K -\$10K) from 55 Alumni and their spouses. A copy of the balance sheet of the Foundation as of December 31, 2023 is attached.

The Executive Board of the Foundation is extremely pleased with the enthusiastic response (and also some unexpected disappointments) with which the Alumni have embraced and supported the project. Although the effort to reach the target amount of \$1.0M is far off, the Executive Board is appreciative and proud that an initial number of 55 individuals have generously donated to the fund and are encouraged, that, as we embark on the second year of fund raising, our initial donors and new alumni donors will respond generously to enable the Foundation to approach the targeted amount.

The Executive Board has directed that the bank balance, that stands at \$75K be invested in Certificate of Deposit account to generate interest that could be used to defray current expenses - website maintenance and bank & credit card fees. It is hoped, as the Principal amount grows and other investment options are explored, the interest returns would be large enough to tackle bigger and impactful projects at the Medical School in our lifetime.

To our initial foundation donors, our sincerest thanks. Your past donation assures us that you are a strategic philanthropist who invest in organizations which will have a significant impact in future and we enjoin you in our shared vision and ask you to make another donation (perhaps double, triple, or multiples last years amount) and commit to a 3 year continuing pledge. We, of course, need shared and sustainable resources to attain our mutual goal of assisting our Alma Mater to continue to produce world class physicians.

It is our hope that we can count, once again. on your generosity and benevolence.
